When YC Hertfordshire assumed operational responsibility for Cuffley Camp (2009) it was on the basis that the site was self-financing. It was evident that this was not the case. On an annual basis the venue is subsidised by YC Hertfordshire. Since 2009 when YC Hertfordshire started to manage the site it has been subsidised by over £300K.  Since 2011 with the exception of 2016/17 there has been a year on year reduction in the number of customers utilising the centre and given the poor condition of the site without significant investment this downward trend is likely to continue.
Stakeholders: Who will be affected: the public, partners, staff, service users, local Member etc	In the last 18 months (which includes two peak seasons) the key stakeholders are schools and other educational establishments (97%). Cuffley Camp is predominately utilised by educational establishments (97%) of which 82% of children are from primary schools. The total number of people who attended the provision over the period April 2016 – September 2017 was 14,326.

As indicated in Appendix A with the exception of 2016/17 there has been a year on year decrease in the number of individuals attending the site. Since 2011 there has been an overall 11% decline. In 2016/17 there was a slight increase in the number of individuals attending the centre due to an increase in two day residentials (i.e. overnight stay) however, there was a 30% reduction in the five day residentials.

From previous years data, approximately 75% of individuals attend the centre from April – September, therefore based on this information, the estimated number of individuals attending the centre in 2017/18 will be approximately 7,400. This will be a decrease from 2016/17.

Information gathered since April 2016 puts the proportion of children who attend from out of county schools at 23%. This does not include those who have academy status. When looking at bookings from independent schools (both in and out of county) over a similar period the proportion of children attending the centre from these booking is 9%.

With the exception of special schools and education support centres, the data collected by Cuffley Camp does not include a breakdown of protected characteristics. From April 2016, 0.11% of children visiting the centre come from special schools and 0.24% from educational support centres.

In addition to working with schools, Cuffley Camp has offered a summer holiday and half term day time provision targeting primary school children. This accounts for 2% of the individuals attending the centre between April 2016 and September 2017. The average daily attendance is 8 children. These come from the surrounding area: Broxbourne, Cheshunt, Cuffley, Ware, Brookmans Park and North London. The cost of a holiday session is £24 per day.

# Disability Including Learning Disability

There is unlikely to be a significant impact on children with this protected characteristic. This is based on the fact that only 0.1% of use is by children from special schools (1 school) and 0.24% from education support centres (3 centres).

There is the potential for a negative impact on children with a learning disability, who may find it more challenging to travel to and familiarise themselves with alternative provision.

Wherever possible we would look to accommodate these bookings at Hudnall Park which is more suitable for children with physical disabilities with respect to access and accommodation.

In addition Hudnall Park is ideally suitable for children with learning disabilities or difficulties as none of its boundaries are next to busy roads, hence there is an increase level of safety and limited road noise.

Currently only one special needs school utilises Cuffley Camp. They are located on the west side of the county which means Hudnall Park would be closer.

Out of the 2 educational support centres which utilise Cuffley Camp, the travel time to Hudnall Park would be similar, however for the other two it would increase by about 20 minutes. Whilst Hudnall Park is still viable if needed we would look to offer these education support centres an outreach service.

Race	The data available on usage at Cuffley Camp does not routinely include information on users' ethnic background. We are therefore unable to identify any potential for a differential impact on people due to their ethnic background.  Currently 22% of users are from schools in the outer London area. It is not clear whether these locations would have a higher proportion of children from black and minority ethnic (BME) backgrounds – if they did, there may be the potential for a negative impact on people from BME communities who may find it more difficult to travel to equivalent alternative provision if it was further away.	As with all current and previous customers, if the decision is made surrender the lease HCC will be contacting schools and working with them to identify other potential suitable providers. # Carers (by association with any of the above)

Given that the majority of users are school groups and that the children are transported by coach, it is unlikely that there will be an impact on those with the protected characteristic of carers.

For carers utilising the holiday schemes they may be required to travel further to alternative facilities, which will add further pressures on their time. However this is expected to be minimal.

There are alternative childcare facilities, summer play-schemes etc. in the local area and any impact would be mitigated by sign-posting to similar alternative provision.

Some families use Cuffley Camp as a holiday resource and this may potentially impact on those with caring responsibilities.

There are alternative childcare facilities, summer play-schemes etc. in the local area and any impact would be mitigated by sign-posting to similar alternative provision.

#### Opportunity to advance equality of opportunity and/or foster good relations

The service has identified 31 alternative outdoor activities and residential providers within 90 minutes of Cuffley Camp with over 6,000 residential spaces. Given the distances which some schools travel to Cuffley Camp there are other providers who are located closer to them.

If the decision to surrender the lease is agreed then HCC will work with customers to identify suitable alternative providers to minimise the impact.

Although Hudnall Park, which is an HCC outdoor educational centre, does not have the same capacity as Cuffley Camp, where possible HCC will look to accommodate customers at Hudnall Park. The centre is looking to increase its camping facilities in 2018 which will increase the capacity. With the exception of the high ropes course Hudnall Park has a similar offer to Cuffley Camp and is situated in a rural location which is safe for children. With the addition of the new toilet and shower block, Hudnall Park is better equipped to cater for individuals with limited mobility.

It is not envisaged that the surrender of the lease at Cuffley Camp will have an impact on traffic congestion as most children are transported to residential centres via coach.

Signposting current customers to a range of alternative provision available may help raise awareness of wider community facilities available in the county,

The relatively high level the information collected appears to be sufficient to identify the likely equalities impact. The vast majority of users are primary aged school children who will be supported to access this type of resource in a planned way through school trips. The impact on those with protected characteristics can be readily mitigated by use of alternative providers and support through the provision of other services generally available, for example, support that would be specified within a child's Education Health and Care Plan.

Staff have been kept informed of the challenges which have faced the centre. If the decision to surrender the lease is agreed then a formal consultation will be carried out with them as part of HCC Change Management Process.

By withdrawing this provision there is a potential impact on children's access to opportunities for learning outside the classroom, however, as there are many outdoor activity and residential centres in and around Hertfordshire some of which may be closer to the service users, the impact will be limited.

If the decision to surrender the lease is agreed, Children's Services will be working with schools to identify suitable alternative facilities. Where possible, HCC will look to accommodate schools at Hudnall Park.
