NASCOT LAWN RESPITE PROVISION

1. Purpose of report

1.1 The report attached as Appendix A from Herts Valleys Clinical Commissioning Group (HVCCG) is to assist members handling of this as an "information" only item at this Committee meeting. It provides the background to the decision by the CCG to cease funding provision at Nascot Lawn.

2. Summary and Background

- 2.1 Nascot Lawn provides respite care for children and young people with complex care needs. It is funded and commissioned by HVCCG and East & North Herts CCG (ENHCCG) and the service is provided by Hertfordshire Community Trust.
- 2.2 HVCCG, as part of its financial turnaround, is reviewing all its expenditure. Consequently, it has identified that the funding it provides towards Nascot Lawn is discretionary and therefore outside its statutory obligation, which is to provide health care services.
- 2.3 However, the Courts have considered the statutory responsibilities of health bodies to provide this type of service and have clearly indicated that when an individual's primary need for a service is a health need then the responsibility is that of the NHS. This includes respite care for children and young people with complex care needs and their carers.
