PART I ('OPEN') BUSINESS

CHAIRMAN'S ANNOUNCEMENTS

The Committee noted that Tom Hawkyard, Head of Scrutiny was still absent from work due to an operation, and wished him a speedy recovery.

MINUTES

The Minutes of the meeting of the Committee held on Wednesday, 4 November 2015 were confirmed as a correct record and signed by the Chairman.

1 INTEGRATED PLAN PROPOSALS 2016/17 AND FUTURE YEARS

ACTION

- 1.1 The Assistant Director Finance, Resources and Performance, provided the Committee with an overview of the Integrated Plan Proposals (IPP) for 2016/17 and future years. The briefing provided Members with an overview prior to undertaking their scrutiny of the Council's 'Integrated Plan Proposals (IPP) for 2016/17 and future years' early in the New Year. Members were provided with a timetable for the plan and received information regarding strategic direction plans, revenue budget and funding, the pressures and inflation.
- 1.2 Members were informed the IPP pack would be a similar format to previous years, although it would be indexed in Cabinet Panel order to ease navigation. The Committee was informed that there would be 2 new sections in the IPP pack; Insurance and Risk Strategy; and Invest to Transform (to show how resources were used). The IPP pack would also contain information in relation to all general and specific reserves.
- 1.3 Officers confirmed that, in order to meet the £56.4 million savings required over a three year period, £19.9 million savings were required to close the gap for 2016/17. It was noted that one of the key pressures facing the Authority was the National Living Wage (NLW) and the impact on National Insurance of the contracted out rebates. Members were informed the majority of employees were paid above the National Living wage; it was mainly school and contracted Care Workers where there would be a pressure some of which was to maintain the differential in pay. Other key pressures included previous policy decision; demography; capital financing and interest on balances and one off contribution to the Pension Fund.
- 1.4 It was noted that following on from the Spending Review on 25 November 2015, Local Authorities were able to levy an additional 2% precept above the limit for council tax increases. The precept was to be used for the purpose of adult social care services. Members were informed that officers expected to have revised figures by mid-December when the Government announced the provisional Local Government Finance Settlement, this was expected to include:
 - reduction in core central Government funding
 - reduction in grants for Public Health
 - reduction in New Homes Bonus (movement of funding to supported care)
 - reduction in Education funding
